CONDITIONS

Pensioners must be 60 years of age or older, own property and personally occupy the property. The property value must be less than R2 000 000.

Pensioners dependent on a National Security Grant qualify for 100% rebate on successful applications.

Pensioners who are not on National Security Grant, but whose gross monthly income falls below R7 000 qualify for 100% rebate on successful application.

Pensioners who are not on National Security Grant, but whose gross monthly income is above R7 000 but less than R12 000 qualify for 50% rebate on successful application.

In case of dual ownership, at least one of the owners must be 60 years of age or older.
